National context

- NHSE, DEFRA, DHSC, NASP, Sport England
- April 2021 - March 2023
- £500k over two years; 7 test and learn sites
- MH focus, particularly most disadvantaged communities
- Promoting the benefits of connection with nature for wellbeing (including indoors/outdoors, alone/in groups)
- Social prescribing context
- Project management approach
- Test and learn programme – what it is and...

What the project is not:





- Reinventing the wheel as there is well-documented evidence of benefits of nature-based activity for wellbeing and MH
- Creating new interventions where we have existing activity in communities
- Simply a thing to be updated on; we're seeking engagement to lead to system change, and

What the project is:

- A programme working towards system change, including colleagues **across** the system
- Identifying barriers and challenges in SP, and working to remove them
- Aiming to create a system with a sustainable place for green providers to thrive and deliver
- A complex challenge, but is needed for long term benefit
- A showcase of partnership working across sectors

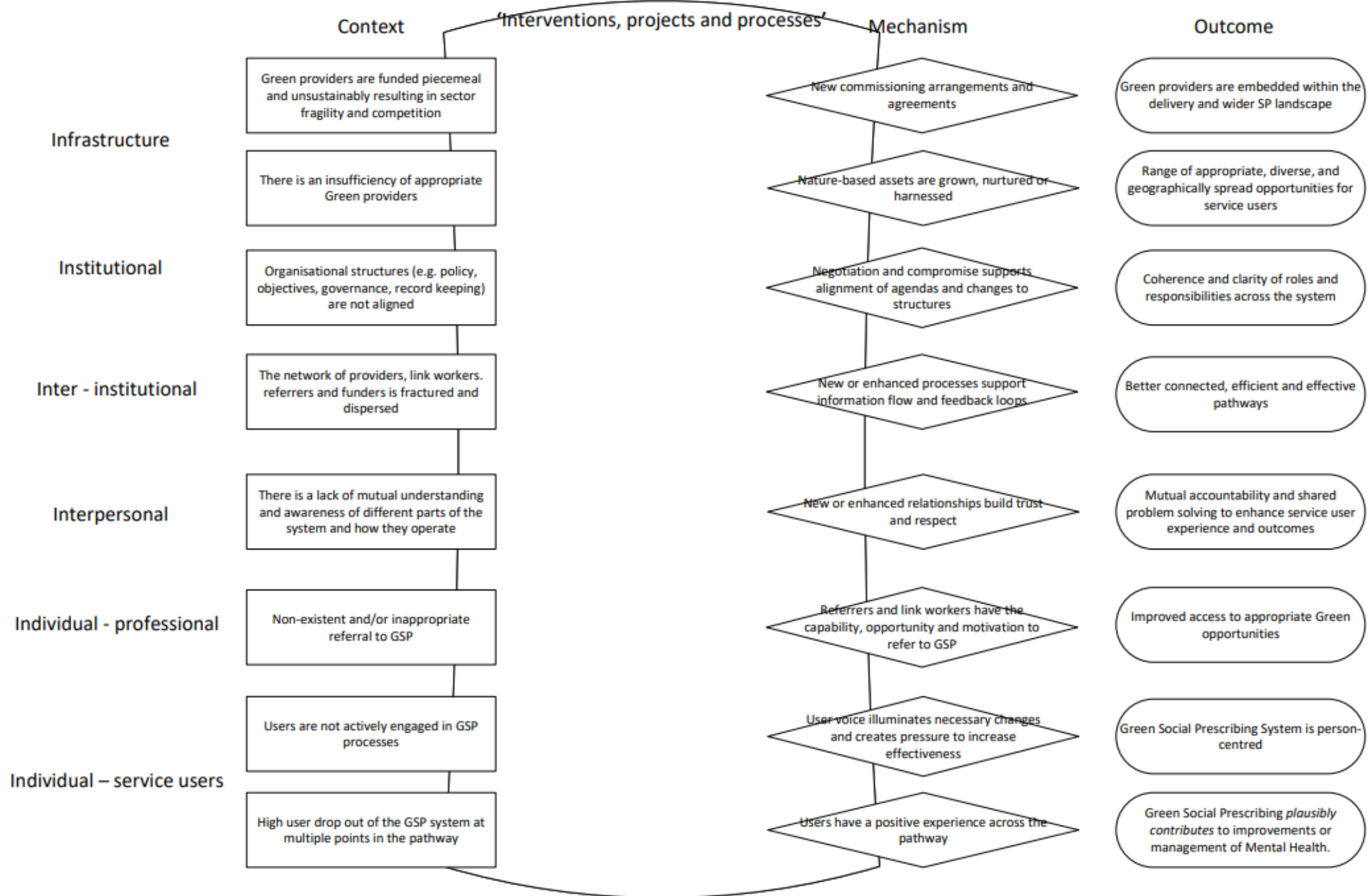

Learning/challenges

- Providers' referrals primarily through alternative community routes
- Referrals not made across levels (see previous slide)
- Range of concerns around making referrals
- 'Social prescribers' – not clear what their remit is, lack of confidence, SPLW, etc.
- Lack of sustainable funding for providers to deliver
- Existing commissioning and funding arrangements are too prohibitive for small organisations to contend with

GreenSPring is digging deeper into these issues, to increase understanding and find collaborative approaches to problem solving

Transformative change – high level programme theory

Our aim

Embed Green Social Prescribing in the longer term as a recognised and valued approach to improving individuals' mental health and wellbeing.

So far:

- Relationship building; developing a shared language/understanding
- Auditing green activity, provider support and community SP experience
- Understanding referrer and provider perspectives
- Exploring investment opportunities for sustainability and recognition of value
- Understand range and benefit of wellbeing/impact measures in use
- Testing referral processes and initiating network development

Next:

Network of green providers

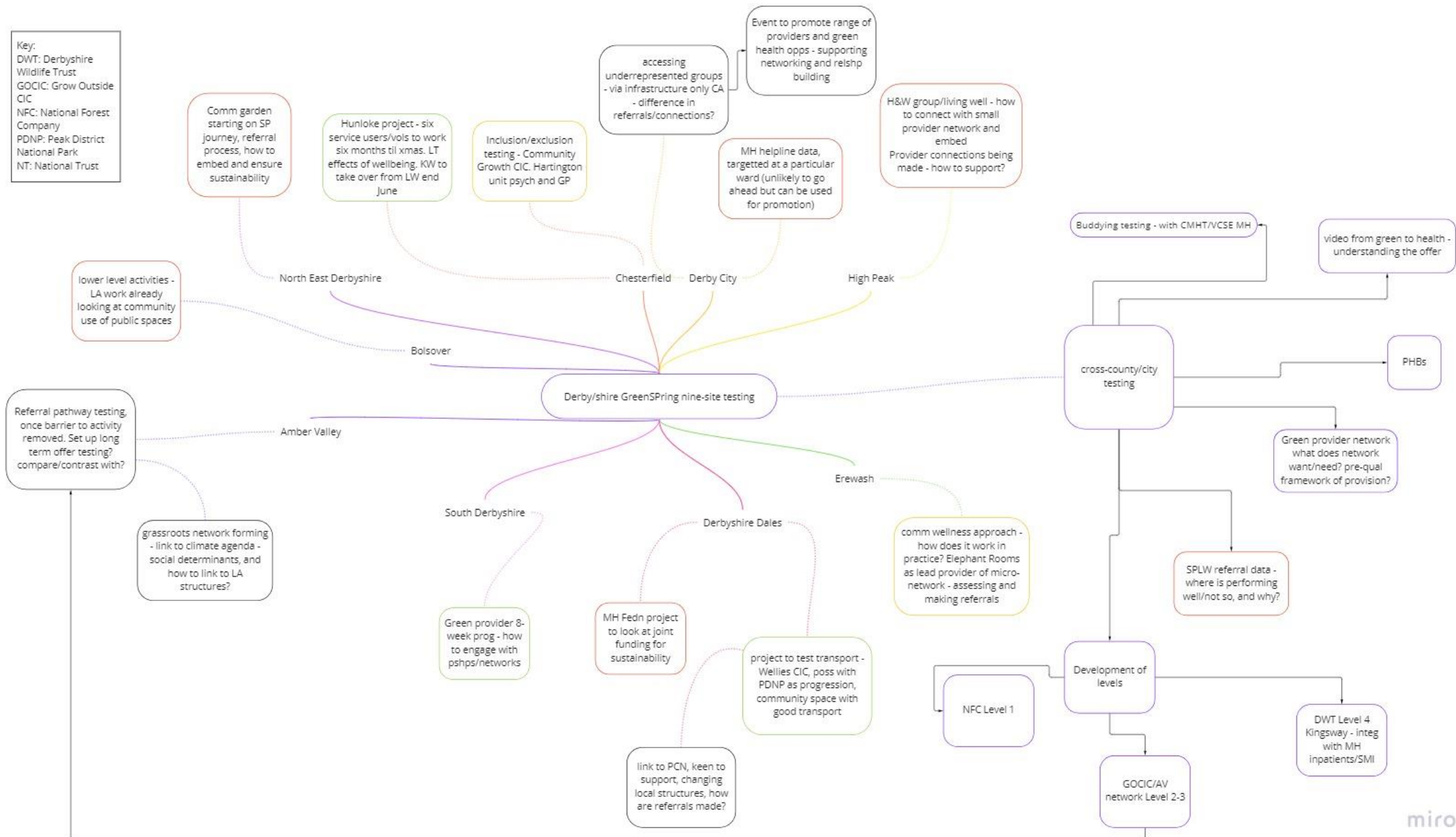
Testing nine boroughs/districts, approach tailored to each locality and informed by cross-sector intelligence of need and existing provision

From ICS Implementation Guidance:

- The VCSE sector is a key strategic partner with an important contribution to make in shaping, improving and delivering services, and developing and implementing plans to tackle the wider determinants of health
- VCSE partnership should be embedded in how the ICS operates, including through involvement in governance structures in population health management and service redesign work, and in system workforce, leadership and organisational development plans.
